

## POSTDOCTORAL RESEARCH FELLOWSHIP

A Postdoctoral Research Fellowship (SKO 1352) is available at the Department of Archeology, History and Conservation, University of Oslo.

The position is associated with the research group on Environmental-, Energy- and Climate-History (KLIMER) [[link to web page](#)].

Applicants should propose a research project relevant for the research group and that engages the histories of the environment, energy or climate in their mental or material configurations.

The position is available for a period of 3,5 years. There is a 25 % component of the position which is devoted to teaching and administrative duties. These duties include obtaining basic teaching qualifications. Teaching and administrative duties will mainly consist of contribution to the concept, development and teaching of a new interdisciplinary MA program in Environmental Humanities.

The successful candidate is expected to become part of the research environment/network of the department and contribute to its development. The main purpose of postdoctoral research fellowships is to qualify researchers for work in higher academic positions within their disciplines.

### Requirements

- PhD or equivalent academic qualifications with a specialization in environmental history or environmental archeology or another discipline of the Environmental Humanities with a historical focus.
- The candidate's research project must engage the histories of the environment, energy or climate in their mental or material configurations.
- Fluent oral and written communication skills in English. Competence in a Scandinavian language is desirable.
- Personal suitability and motivation for the position

The doctoral dissertation must be submitted for evaluation by the closing date. Appointment is dependent on the public defence of the doctoral thesis being approved.

In the evaluation of the applications, emphasis will be placed on:

- The research project's scientific merit, research-related relevance and innovation
- The applicant's estimated academic and personal ability to carry out the project within the allotted time frame and contribute to the research group.
- A track record in the Environmental Humanities with a focus on historical perspectives and conceptual work.
- Good co-operative skills, and the ability to successfully join in academic collaboration within and across disciplines

## How to apply

The application must include

- Application letter describing the applicant's qualifications and motivation for the position
- Curriculum Vitae with grades listed (with a list of education, positions, teaching experience, administrative experience and other qualifying activities)
- List of publications
- Project description (approx. 3 - 5 pages, maximum 14,000 characters. See [Template for project descriptions](#)). The project description must present a feasible progress plan. It is expected that the applicant will be able to complete the project during the period of appointment

Diplomas, certificates, doctoral thesis and other academic works may be requested later.

Please note that all documents must be in English or a Scandinavian language.

The application with attachments must be delivered in our electronic recruiting system, jobbno. Applicants with education from a foreign university must attach an explanation of their university's grading system.

The short-listed candidates will be invited for an interview.
