Job description

Two positions of Senior lecturer (SKO 1198) in Philosophy are available at the <u>Department of Philosophy</u>, Classics, History of Art and Ideas, University of Oslo.

The vacancy is a teaching position, with 75 % teaching and dissemination work, 19 % academic development work, and 6 % administration. The position is based in the Philosophy section and the persons appointed will be part of this professional environment. The teaching will primarily be related to Examen Philosophicum (Exphil). The Department provides the teaching and examination of Exphil for all students enrolled in UiO´s programmes, in all around 2000 students per semester. The teaching is delivered through both large lectures and smaller seminars requiring obligatory assignments and attendance. They should also be prepared to assume administrative responsibilities, for example as members of councils and committees. Within the normal duties and academic competence, the persons appointed may also be directed to work outside their department. The appointment is made on condition that changes to the subject area and tasks may be determined by the employer.

Qualification requirements

- PhD or equivalent academic qualifications with a specialization in Philosophy
- Personal suitability and motivation for the position
- Experience in teaching and interest in pedagogical development
- The ability to teach in Norwegian, Swedish or Danish language from the start date

In the evaluation of the applicants, emphasis will be placed on:

- Pedagogical qualifications and practice, mainly from universities or higher education institutions, see <u>How to document your pedagogical skills</u>
- Pedagogical qualifications, documented results from teaching and supervision, and ability to inspire students
- Experience in producing text books, compilations and lecture notes or experience in internet based teaching/flexible learning
- Interest and ability in leadership and administration
- Good teamwork skills and experience
- Professional competence and publications in the field

In the case of applicants who are equally qualified, emphasis may be given to the applicant's professional profile and ability to teach in areas where the philosophy programmes have or will have teaching needs.

The successful candidate who at the time of appointment cannot document basic teaching qualifications will be required to obtain such qualifications within a two-year period.
