DOCTORAL RESEARCH FELLOWSHIP IN MUSICOLOGY – SOCIETAL CHALLENGES AND CRISES

Job description

A Doctoral Research Fellowship (SKO 1017) in musicology is available at the Department of [Musicology](#), University of Oslo.

"The Department of Musicology (IMV), University of Oslo, is pleased to announce three fully funded PhD Fellowships in music research. We seek candidates with the potential to develop the field of musicology and invite research proposals that engage with the broader theme of societal challenges and crises from various methodological perspectives. The positions are open with regard to time period, geographic area, and precise musical genre or tradition. The department conducts research in a wide range of areas including music history, analysis, cognition and technology, jazz and popular music, the cultural study of music, and music and media. Applicants should explicitly state how their proposals align with the research competencies at the Department of Musicology. The successful candidates will be expected to complement and contribute to the strong research profile of our department."

The person appointed will be affiliated with the Faculty's organized research training. The academic work is to result in a doctoral thesis that will be defended at the Faculty with a view to obtaining the degree of PhD. The successful candidate is expected to join the existing research milieu or network and contribute to its development. Read more about the [doctoral degree](#).

The appointment is for a duration of 3 years. All PhD Candidates who submit their doctoral dissertation for assessment with a written recommendation from their supervisor within 3 years or 3 ½ years after the start of their PhD position, will be offered, respectively, a 12 or 6 month [Completion Grant](#).

Qualification requirements

- A Master's degree in musicology or in a field that builds a solid foundation for research into the area of the chosen topic. The applicant is required to document specifically that the degree corresponds to the profile for the post.
- The Master's degree must have been obtained and the final evaluation must be available by the application deadline.
- Fluent oral and written communication skills in English, see [Language requirements](#). For project proposals that deal with the Nordic region, fluency in Norwegian or another Scandinavian language.
- Personal suitability and motivation for the position.

To be eligible for admission to the doctoral programmes at the University of Oslo, applicants must, as a minimum, have completed a five-year graduation course (Master's degree or equivalent), including a master's thesis of at least 30 ECTS. In special cases, the Faculty may grant admission on the basis of a one-year Master course following an assessment of the study programme's scope and quality.

In assessing the applications, special emphasis will be placed on:

- The project's scientific merit, research-related relevance and innovation
- The applicant's estimated academic and personal ability to complete the project within the time frame
- The applicant's ability to complete research training
- Good collaboration skills and an ability to join interdisciplinary academic communities

Applicants who have recently graduated with excellent results may be given preference.

The application must include:

- Application letter describing the applicant's qualifications and motivation for the position
- Curriculum Vitae (with a list of education, positions, teaching experience, administrative experience and other qualifying activities, including a complete list of publications)
- Transcript of records of your Bachelor's and Master's degrees. Applicants with education from a foreign university must attach an explanation of their university's grading system
- Documentation of [Language requirements](#) (if applicable)
- Project description, including a detailed progress plan for the project (3 - 5 pages, maximum 14,000 characters. See [Template for project descriptions](#))

Please note that all documents must be in English or a Scandinavian language.

Educational certificates, master theses and the like are not to be submitted with the application, but applicants may be asked to submit such information or works later.

The application with attachments must be delivered in our electronic recruiting system, [jobbnoe.no](#).

Short-listed candidates will be invited for an interview.
